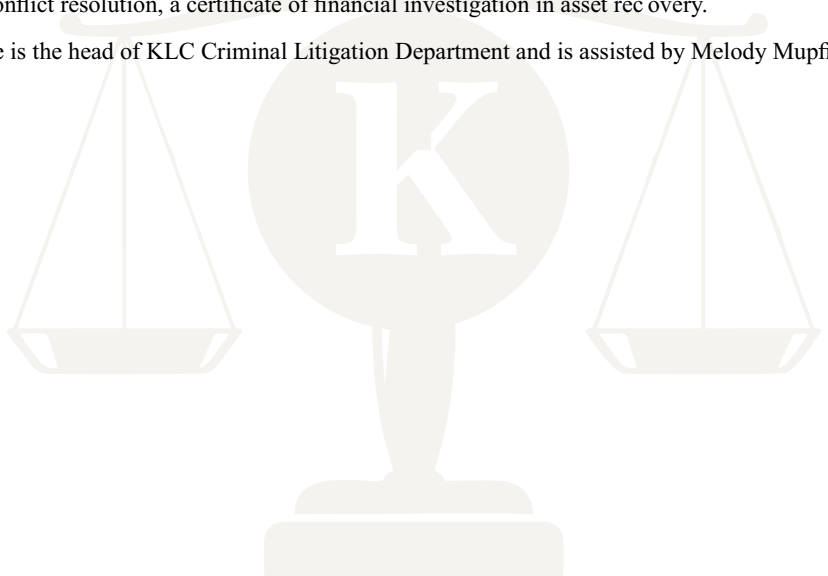


Arthur Bosha

- He is the head of KLC Criminal Litigation Department and is assisted by Melody Mupfiga.



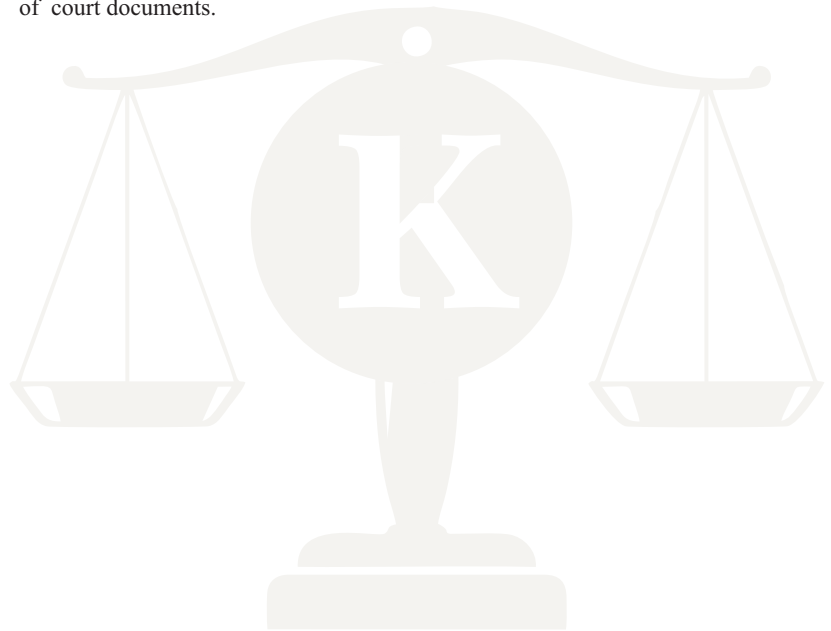
